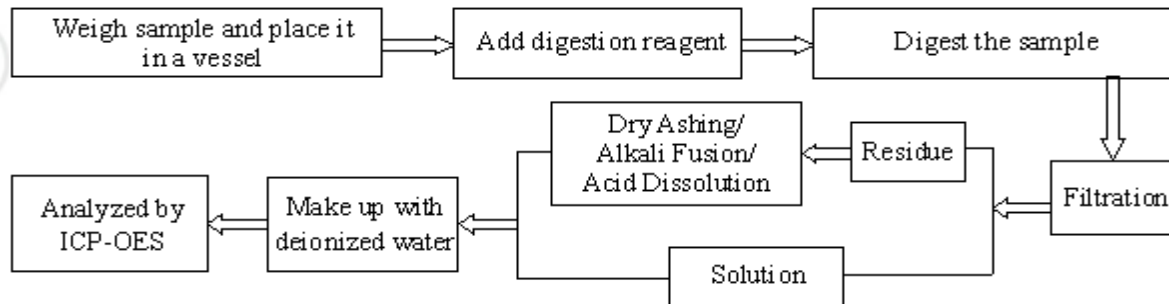

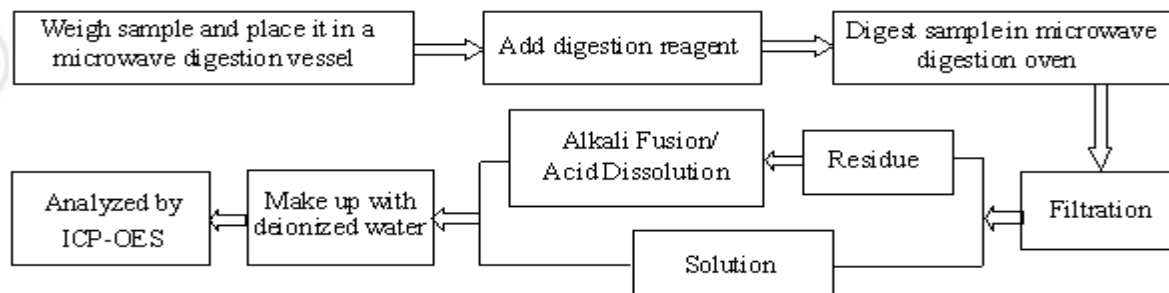

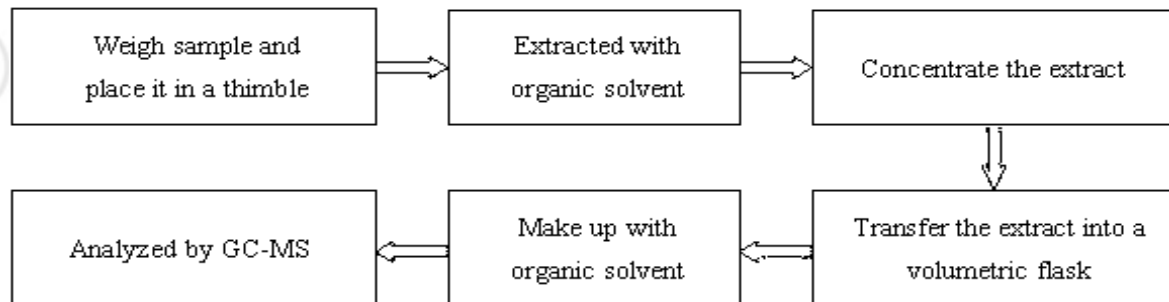
1. Lead (Pb), Cadmium (Cd), Chromium (Cr)



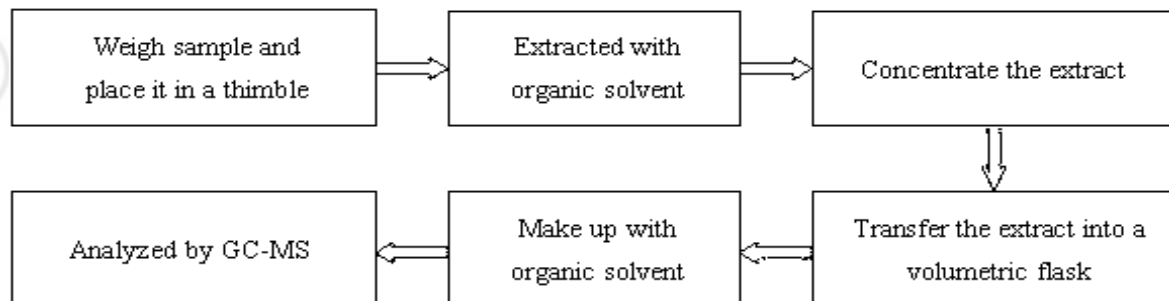
2. Mercury (Hg)

4. Phthalates(DBP, BBP, DEHP, DIBP)

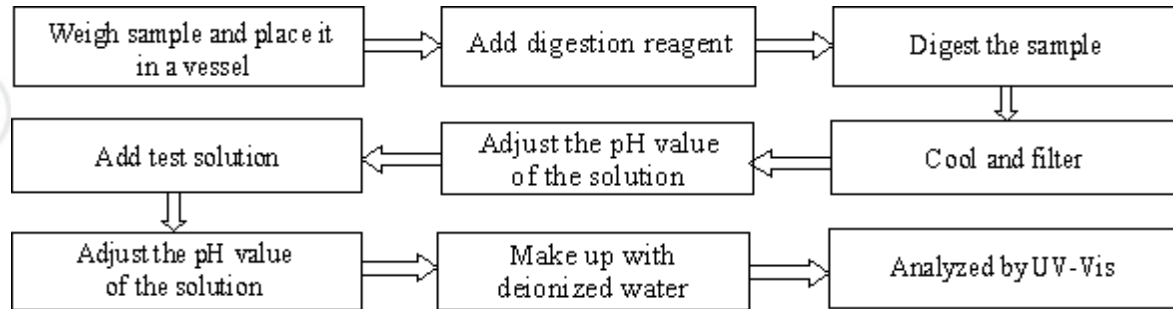

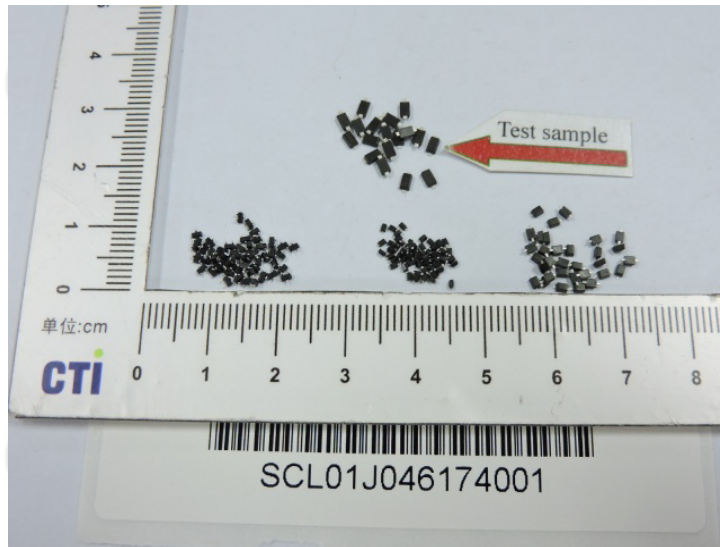
